Situated on the on the southern side of Cork city this site represents an excellent opportunity to acquire a strategic site bounding Cork Airport. Currently in Agricultural use the entirety of the parcel lies within an area Zoned "Cork Airport Infrastructure" in the current City Development plan. The property is easily accessed from both the Togher Road and the Pouladuff Road via Lehenaghmore.





Location

Within easy access of the southern suburbs the property is accessed from the south ring road by taking the Togher exit coming from the Kinsale Road Roundabout and taking the Lehenaghmore Exit off the roundabout on the Pouladuff Road. Continue on straight up the hill passing manor Farm, Matthew Hill and Lehenaghmore Park. The land is o the left hand side of the road before the sharp turn to the right.



Description

The property comprises a c.23 acre potential development site which is currently in agricultural use. The land in general slopes gently down from its Eastern boundary to its Western boundary. It is bounded by a mix of agricultural users, a local soccer club as well as Cork Airport to the South.

ZO 21 1

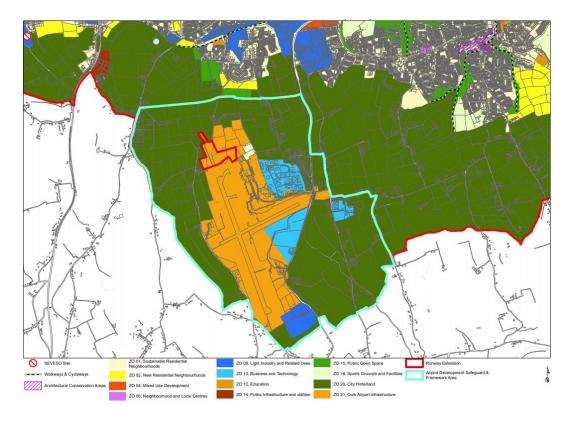
The primary objective of this zone is to encourage land uses which promote and support the operations of Cork International Airport, subject to normal planning considerations. ZO 21.2

Such uses include but are not restricted to: general aviation activity; air transport infrastructure including but not limited to the expansion of the main terminal including additional and enhanced security facilities, additional gates, expansion of airside retail concession and leisure facilities, and limited expansion of landside concession facilities; future extension and expansion of runways and aprons including but not limited to the Runway End Safety Area and other infrastructure associated with operations of the runway; refurbishment and re-use of former terminal for Airport related commercial uses; expansion of Airport Hotel; expansion of long-term parking facilities and limited expansion of staff parking facilities; construction of bus / coach terminal; expansion of taxi facilities;

defined car hire location; petrol filling station in an appropriate location, if relocated, and ancillary retail. This list is not intended to be exhaustive and the other developments not listed will be considered, subject to normal planning and environmental considerations. ZO 21.3

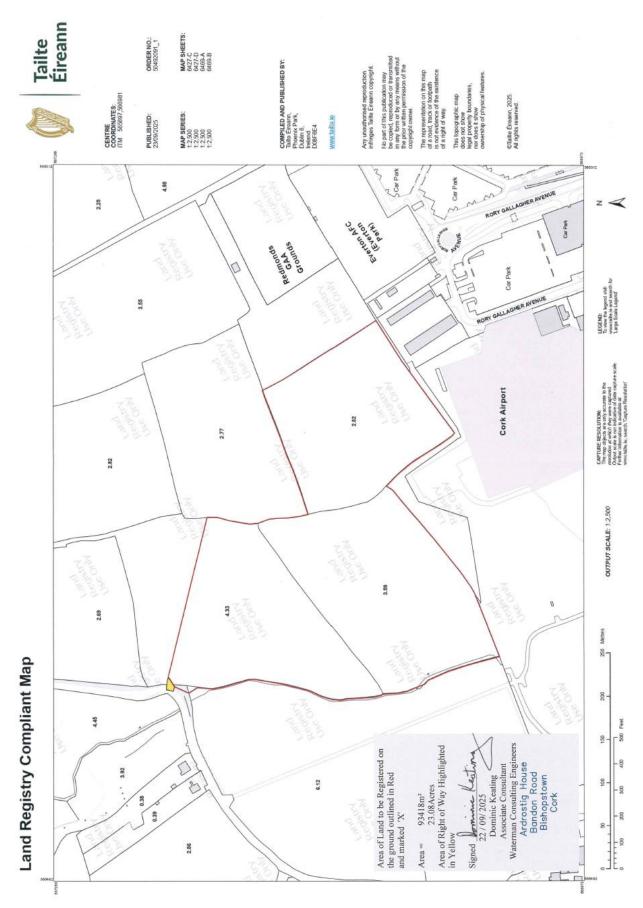
Approximately 17 acres (outline in red below) of the 23 acres lie within an area designate for "Runway Extension"
